**APPLICATION INSTRUCTIONS AND REQUIREMENTS**

Each team participating in the reality television series currently entitled "Crowned" (the "Series") must consist of a Mother and her Daughter, each of whom must be at least 18 years of age as of the date this application is submitted. Each teammate must complete her own individual application. Both applications must be submitted together accompanied by a DVD, Mini DV or VHS tape (the "Video") of both members of the team, which should be no longer than 10 minutes. No beauty pageant experience is necessary or required. We welcome all applications.

**WHAT TO DO IN YOUR VIDEO:**

Show us who you are and why you are the perfect Mother/Daughter team for Crowned. Take us on a tour of your lives and show us what separates your team from all the others. WOW us, DAZZLE us, and be memorable! Remember, Crowned is like a **beauty** contest so **personality** and **creativity** count as well!

**BEFORE SENDING YOUR VIDEO:**

Watch your Video back and make sure that we can clearly **hear** and **see** both of you.

The Video will be retained by, and become the property of, Crowned Productions, Inc. ("Producer") and will not be returned to you, regardless of whether or not you are selected as a Series participant and Producer will own all rights including, without limitation, the copyright in and to the Video.

**COMPLETED APPLICATION SUBMISSIONS INCLUDE THE FOLLOWING:**

- Completed application for each teammate, i.e. **2 applications.**
- Copy or proof of eligibility to live and work in the United States for both the Mother and her Daughter (either valid US passport or combination of valid US driver's license and valid social security card)
- A separate photo of each applicant and a recent photo of both team members together.
- One Video (which should be a maximum 10 minutes in duration) of your team clearly labeled with your names.

**APPLICATION RULES AND REQUIREMENTS:**

This application is for casting of a reality-based television show currently entitled "Crowned" whose purpose is entertainment.

The following eligibility requirements must be met in order to proceed with the application process:

- I. You must be legally eligible to be and work in the United States and live in the United States. Proof of such eligibility must be provided to the Producer. Acceptable forms of proof include, without limitation, a valid US passport or combination of valid US driver's license and valid social security card.
- II. You must be a female.
- III. Each team must consist of a Mother and her Daughter. The definition of Mother and Daughter shall be determined in Producer's sole discretion.
- IV. You must be at least 18 years of age as of the date that you submit this application.
- V. You must be in excellent physical and mental health. All applicants who believe they meet Producer's criteria, including persons with disabilities, are welcome and encouraged to apply to be a Series participant.
- VI. You must not now be a candidate for public office and must agree not to become one until six months after initial broadcast of all episodes of the Series in which you appear, if selected as a Series participant.
- VII. If selected for an interview, you must timely and fully complete a longer application. The Producer will provide the additional application to potential interviewees.
- VIII. Any offer to become a Series participant is conditioned upon the following: your timely and fully completing a Background Questionnaire Form and authorization to obtain background information from third parties; your submission to physical and psychological examinations to be conducted in Los Angeles, CA, by medical professionals selected by and paid for by the Producer and the certification of the medical professionals that you meet all physical and psychological requirements; and your signing a Participant Agreement, among other documents, as required by Producer.
- IX. At Producer's request, you must be willing to travel to Los Angeles, CA, for up to 7 days in February 2008 (or as otherwise scheduled by the Producer) for the final selection process. Producer will provide each participant traveling to Los Angeles, CA for the final selection process with: (a) economy air travel (roundtrip to and from Los Angeles, CA, and the nearest major airport to your home in the United States) booked by Producer in accordance with Producer's travel policies or roundtrip ground transportation in the event that your home is within driving distance of Los Angeles, CA as determined by Producer (b) meal expenses in an amount determined by Producer; and (c) lodging (single or double occupancy, room and tax only) as selected, approved, and booked by Producer.
- X. Neither you nor any of your immediate family members or anyone living in your household may be or have been within the past two (2) years employees prior to the date you submit this application, officers, directors or agents of any of the following: (a) Producer, Fox Television Studios, Inc., The CW Network, LLC and/or any of their respective parents, affiliated and subsidiary companies, or broadcast affiliates; (b) any person or entity involved in the development, production, distribution or other exploitation of the Series or any variation thereof; (c) any sponsor of the Series or its advertising agency; or (d) any person or entity supplying services or prizes to the Series. addition, Producer reserves the right to render ineligible any person who Producer determine, in its sole discretion, is sufficiently connected with the production, administration, judging, or distribution of the Series such that his or her participation in the Series could create the appearance of impropriety.

- XI. If you are selected as a Series participant, you must be willing to travel to and reside at one or more undisclosed locations in the United States for approximately five (5) weeks in February/March 2008 (or as otherwise scheduled by the Producer). If you are selected as a Series participant, Producer shall provide you with economy air travel (roundtrip to and from Los Angeles, CA, and the nearest major airport to your home in the United States) booked by Producer in accordance with Producer's travel policies or, in the event that you live within driving distance of the location(s) where the Series is being produced as determined in Producer's sole discretion, Producer shall provide you within roundtrip ground transportation to/from the location(s) where the Series is being produced.
- XII. In order to be selected as a Series participant, you must not have been convicted of a violent crime of any nature or a crime that involves moral turpitude (as determined in Producer's sole discretion) and you must not have been found to be a danger to yourself or others by a court or other tribunal as of the date you submit this application.

Please read, sign and date the following statement:

I hereby acknowledge that (i) I have read, and I meet and agree to be bound by, the Series eligibility requirements; (ii) I have answered the previous questions honestly and accurately; (iii) if any of the above information is found to be false, I understand that this will be grounds for my dismissal from the Series participant selection process and/or from the Series, if selected; (iv) even if I meet the eligibility requirements, the Producer has no obligation to interview me and/or select me as a Series participant, and Producer reserves the right to change any of the eligibility requirements at any time; (v) all decisions by the Producer concerning the selection of the Series participants is final and not subject to challenge or appeal; (vi) I agree to keep strictly confidential all information about the Series that I acquire during the Series participant selection process and/or my participation in the Series; (vii) my voice, actions, and likeness may be recorded as a part of this application and Series participant selection process ("Recordings"), and I understand that Producer may, but is in no way obligated to, actually use such Recordings within the Series; (viii) Producer has no obligation to return any materials submitted by me as part of the Series participant selection process ("Materials") whether or not I am selected as a Series participant, and Producer may, but is in no way obligated to, use any such Materials in and in connection with the Series; (ix) and Producer shall have the right to use the Recordings and the Materials in any manner and by any media now known or hereafter devised, in perpetuity throughout the universe, and in connection with all allied and ancillary rights therein and Producer shall own all rights including, without limitation, the copyrights in and to the Recordings and the Materials.
